

HAWAII NATIONAL BANK'S HOMETOWN HEROES CAMPAIGN OFFICIAL RULES

Sponsor

The Sponsor of this Sweepstakes ("Sponsor") is Hawaii National Bank, 45 North King Street, Honolulu, HI 96817.

Eligibility

Hawaii National Bank's "Hometown Heroes" Campaign ("Sweepstakes") is open to legal U.S. residents of the State of Hawaii with a valid Hawaii mailing address, age 18 years or older at the time of submission/nomination. Employees of Sponsor are not eligible to win. Sweepstakes is governed by U.S. law and subject to all applicable federal, state and local laws and regulations; void where prohibited.

Campaign Period

The Sweepstakes begins May 11, 2020 at 12:00AM (HST) and ends June 19, 2020 at 5:00PM (HST) ("Campaign Period").

Nomination Criteria

Nominees must meet the Eligibility requirements above AND be an individual who is putting themselves at risk for the greater good and/or helping our communities during this COVID-19 pandemic, including, but not limited to: essential service workers (grocery store workers, restaurant/food service workers, financial services workers, security, airlines and transportation workers, farmers, construction workers, shipping and delivery workers, warehouse workers, water and waste-water workers, postal service workers), educators, volunteers (delivering food to kupuna, making Personal Protective Equipment) and front line workers (medical workers, firefighters, police officers).

How to Submit a Nomination

NO PURCHASE NECESSARY TO ENTER OR WIN. Sweepstakes is entered by submitting a nomination for an eligible "Hometown Hero" in the Hawaii community during the Campaign Period. Self-nominations are not allowed. Nominations must be submitted through one of the methods below:

- Public post on Instagram – Post a photo of the nominee, tag the nominee's Instagram profile, write a brief description of the service/contributions made by the "Hometown Hero" nominee in the caption, and tag @hawaiinationalbank AND #HNBHometownHeroes
- Complete and submit the online nomination form on the HNB Hometown Heroes website at <https://heroes.hawaiinational.bank>

Nominations submitted via Instagram must come from profile accounts that follow Sponsor (@hawaiinationalbank) and have profiles set to public. Submissions via private profile accounts, Instagram Stories, direct messages, comments, or other expiring forms will not be eligible. All nominations must be dated within 12:00am HST on May 11, 2020 to 11:59pm HST on June 18, 2020. Limit (1) nomination per person/account per day. You may not submit nominations more times than indicated by using multiple email addresses, identities, or accounts in an attempt to circumvent the rules. Nominations may be removed from eligibility at the sole discretion of Sponsor. Sponsor reserves the right in its sole and absolute discretion to disqualify any entry it deems incomplete, incoherent, illegible, inappropriate or abusive. Sponsor is not responsible for entries and images that are incomplete, illegible, lost, late, inaccurate, undelivered, delayed, misdirected, do not adhere to the rules

or specifications, or cannot be completed due to electronic or technical difficulties, regardless of cause. All nominations become the property of Sponsor and will not be acknowledged or returned.

Winner Selection and Notification

On each Friday in the Campaign Period, eligible nominations will be entered into a random drawing to determine winners (“Recipients”). Recipients will be notified directly from the contact information submitted with their nomination or through direct message on Instagram. Recipients will also be listed weekly on Instagram and on the HNB Hometown Heroes website. The number of Recipients drawn each week will be determined by Sponsor.

Nominators and Recipients will be notified of gift selection and given instructions for receiving the gift. Sponsor shall have no liability for Recipient’s failure to receive notices due to spam or other security settings or for Recipient’s provision of incorrect or otherwise non-functioning contact information. If Recipient cannot be contacted, is ineligible, fails to claim the gift within 5 days from the time award notification was sent, or fails to timely return information and documentation as required, the gift may be forfeited. Sponsor has up to 15 days from receipt of Recipient’s complete contact information to distribute gift. Receipt by Recipient of the gift offered in this Sweepstakes is conditioned upon compliance with any and all federal, state, and local laws and regulations. If Recipient is not reachable at the telephone number or e-mail address provided and a forwarding e-mail address is not made available or if gift notification is returned as undeliverable, then the gift will be forfeited, and an alternate Recipient may be selected.
